Letter from the Chairman

Dear Shareholder,

I am pleased to be writing to you, on behalf of the Board of Directors (the "Board"), with details of the Annual General Meeting (the "AGM") of Gresham House plc (the "Company") which will be held at 1 Wood Street, London, EC2V 7WS on Thursday, 12 May 2022 at 2.00pm.

## **Q&A Submission**

This year, we are encouraging all questions to be submitted in advance of the AGM and, in order to cover as many questions as possible, it would be appreciated if shareholders could submit their questions by Friday, 6 May 2022. ## Amendment to Articles

Shareholders will note that the Notice of AGM contains an additional resolution concerning the proposed amendment of the Articles of Association of the Company. Resolution 11 is proposed as a special resolution, to adopt new Articles of Association (the "New Articles") of the Company.

The purpose of adopting the New Articles is to reflect developments in market practice since the Company's Articles of Association were last amended, which was some time ago (October 2014) and to bring them in line with best practice. The principal changes being proposed in the New Articles are summarised in further detail in the Appendix to the Notice of AGM.

A copy of the New Articles will be available to members for inspection during normal business hours (Saturdays, Sundays and public holidays excluded) at the registered office of the Company at 5 New Street Square, London EC4A 3TW, up until the close of the AGM. # **Explanatory notes**

The following notes give an explanation of the proposed resolutions.

Resolutions 1 to 8 (inclusive) are proposed as Ordinary Resolutions. This means that for each of those resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolutions 9, 10 and 11 are proposed as Special Resolutions. This means that for each of those resolutions to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

The Directors consider the passing of all of the Resolutions to be in the best interests of the Company and its shareholders and accordingly recommend that you vote in favour of these Resolutions as they intend to do in respect of their own shareholdings.

# Resolution 1 - Receive and adopt the Annual Report and Accounts

The Directors of the Company are required to lay the Annual Report and Accounts before the shareholders each year. Resolution 1 is an ordinary resolution to receive and adopt the Company's annual accounts, together with the Directors' Report and Auditor's Report on the accounts, for the financial year ended 31 December 2021.

## Resolution 2 - Declaration of dividend

The Directors recommend that shareholders approve a final dividend for the year to 31 December 2021 of 10.0 pence per share. The final dividend cannot exceed the amount recommended by the Directors. If approved, it will be paid on 27 May 2022 to shareholders on the Register of Members at the close of business on 12 May 2022.

# Resolution 3, 4 and 5 - Re-election of Directors

The articles of association of the Company require a certain number of the Directors to retire by rotation at each Annual General Meeting. At the AGM, Richard Chadwick, Anthony Townsend, Anthony Dalwood and Gareth Davis will retire. In line with plans announced at the time of last year's Annual General Meeting, Richard Chadwick will retire from the board from the conclusion of this year's Annual General Meeting and will not seek re-election. Anthony Townsend, Anthony Dalwood and Gareth Davis are each offering themselves for re-election and Resolutions 3, 4 and 5 propose their re-election as Directors.

## Resolution 6 - Reappointment of auditor

This resolution concerns the reappointment of BDO LLP as the Company's auditor until the conclusion of the Company's next Annual General Meeting.

# Resolution 7 - Auditor's remuneration

This resolution authorises the Directors to determine the auditor's remuneration.

# Resolution 8 - Authority to allot shares or grant subscription or conversion rights

This resolution asks shareholders to grant the Directors authority under section 551 of the Act to allot shares or grant such subscription or conversion rights as are contemplated by sections 551(1)(a) and (b) respectively of the Act up to a maximum aggregate nominal value of £6,378,999, being approximately two thirds of the nominal value of the issued ordinary share capital of the Company as at 8 April 2022 (being the latest practicable date prior to the publication of this Notice of AGM). As at 8 April 2022, the Company held no treasury shares (as defined in the Act). In accordance with the latest guidelines issued by The Investment Association, up to an aggregate nominal value of £3,189,499 of this authority is reserved for a rights issue or other pre-emptive offer to ordinary shareholders, representing approximately one third (33.33%) of the nominal value of the Company's issued share capital as at 8 April 2022.

This authority will expire at the conclusion of the next Annual General Meeting or the date falling 15 months from the passing of this resolution, whichever is earlier. The Directors consider it important to have the maximum ability and flexibility to raise finance to enable the Company to respond to market developments and conditions. Any allotment or any agreement to allot shares entered into pursuant to previous authorities remains valid. The resolution replaces a similar resolution passed at the last Annual General Meeting of the Company held on 12 May 2021.

# Resolution 9 - Disapplication of pre-emption rights

If the Directors wish to allot new shares or other equity securities for cash, the Act requires that such shares or other equity securities are offered first to existing shareholders in proportion to their existing holdings. The allotment of

equity securities as referred to in this resolution includes the sale of any shares which the Company holds in treasury following a purchase of its own shares.

Resolution 9 asks shareholders to grant the Directors (i) a general authority to allot equity securities for cash up to an aggregate nominal value of £956,849 (being 10% of the nominal value of the Company's issued ordinary share capital as at 8 April 2022) without first offering the securities to existing shareholders.

The resolution also disapplies the statutory pre-emption provisions in connection with a rights issue only in relation to the amount permitted under Resolution 8 above allowing the Directors to make appropriate arrangements in relation to fractional entitlements or other legal or practical problems which might arise.

The authority will expire at the Company's next Annual General Meeting or the date falling 15 months from the passing of the resolution, whichever is earlier. The resolution replaces a similar resolution passed at the Annual General Meeting of the Company held on 12 May 2021.

## Resolution 10 - Purchases of own shares by the Company

Resolution 10 seeks authority from shareholders for the Company to make market purchases of its own ordinary shares, such authority being limited to the purchase of 10% of the ordinary shares in issue as at 8 April 2022. The maximum and minimum prices payable are also stated in the resolution. The authority will only be exercised if the Directors consider that there is likely to be a beneficial impact on earnings per ordinary share and that it is in the best interests of the Company at the time. This resolution replaces a similar resolution passed at the Annual General Meeting of the Company held on 12 May 2021. The Company will be able to hold the ordinary shares which have been repurchased as treasury shares, in accordance with the Act, and resell them for cash, cancel them or use them for the purposes of its employee share schemes.

# Resolution 11 - Adoption of new Articles of Association

It is proposed as a special resolution to adopt new Articles of Association (the **New Articles**) of the Company. The purpose of adopting the New Articles is to reflect developments in market practice since the Company's Articles of Association were last amended, which was some time ago (October 2014) and to bring them in line with best practice. The principal changes being proposed in the New Articles are summarised in the Appendix to this Notice. A copy of the New Articles will be available to members for inspection during normal business hours (Saturdays, Sundays and public holidays excluded) at the registered office of the Company at 5 New Street Square, London EC4A 3TW, up until the close of the AGM. #### **Notes**

#### Entitlement to attend and vote

- 1. Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001 (as amended), the Company specifies that only those members registered on the Company's Register of Members at:
  - 6.00pm on Tuesday, 10 May 2022; or
  - if this AGM is adjourned, at 6.00pm on the day two working days prior to the adjourned AGM,

shall be entitled to attend and vote at the AGM in respect of the number of shares registered in their name at such time.

2. Any member or his or her proxy attending the AGM has the right to ask any question at the AGM relating to the business of the AGM.

# Appointment of proxies

- 3. If you are a member of the Company at the time set out in note 1 above, you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at the AGM and you should have received a proxy form with this Notice of AGM. You can only appoint a proxy using the procedures set out in these notes and the notes to the proxy form. A member may appoint more than one proxy to attend the AGM, provided each proxy is appointed to exercise the rights attached to a different share or shares held by that member (the number of shares in respect of which each proxy is appointed must be specified). The right to appoint a proxy does not apply to any person to whom this notice is sent who is a person nominated under section 146 of the Companies Act 2006 (the "Act") to enjoy information rights (a "Nominated Person").

- 5. A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against the resolution. - in any related documents (including the Chairman's letter and proxy form),

to communicate with the Company for any purposes other than those expressly stated in this Notice of AGM.

## Information to be published

- 14. The information required to be published by section 311(A) of the Act (information about the contents of this notice and numbers of shares in the Company and voting rights exercisable at the AGM and details of any members' statements, members' resolutions and members' items of business received after the date of this Notice) may be found at <a href="https://www.greshamhouse.com">www.greshamhouse.com</a>.
- 15. Members representing 5% or more of the total voting rights of all the members or at least 100 persons (being either members who have a right to vote at the AGM and hold shares on which there has been paid up an average sum, per member, of £100 or persons satisfying the requirements set out in section 153(2) of the Act) may require the Company, under section 527 of the Act, to publish on a website a statement setting out any matter relating to: (i) the audit of the Company's accounts (including the Auditor's Report and the conduct of the audit) that are to be laid before the AGM; or (ii) any circumstance connected with an auditor of the Company ceasing to hold office since the previous Annual General Meeting at which annual accounts and reports were laid in accordance with section 437 of the Act. The business which may be dealt with at the AGM includes any statement that the Company has been required under section 527 of the Act to publish on a website.

## **Nominated Person**

- 16. A Nominated Person may, under an agreement between them and the member who nominated them, have a right to be appointed (or to have someone else appointed) as a proxy entitled to attend and speak and vote at the AGM. Nominated Persons are advised to contact the member who nominated them for further information on this and the procedure for appointing any such proxy.
- 17. If a Nominated Person does not have a right to be appointed, or to have someone else appointed as a proxy for the AGM or does not wish to exercise such a right, they may still have the right under an agreement between themselves and the member who nominated them to give instructions to the member as to the exercise of voting rights at the AGM.

## **APPENDIX:**

# Explanatory notes on the principal changes proposed to the Company's articles of association

The following sets out brief explanatory notes on the principal changes proposed to be made to the Company's existing Articles of Association (the "Current Articles") as contained in the articles of association being proposed for adoption at the Annual General Meeting (the "New Articles"). References below to article numbers are to the New Articles, unless otherwise stated. The New Articles also include a range of minor consequential and clarifying amendments which are not set out below.

A copy of the New Articles will be available to members for inspection during normal business hours (Saturdays, Sundays and public holidays excluded) at the registered office of the Company at 5 New Street Square, London EC4A 3TW, up until the close of the AGM. A copy can be requested via email at <a href="mailto:info@greshamhouse.com">info@greshamhouse.com</a> up until the conclusion of the AGM.

## Size of Board (Article 83)

The Current Articles cap the number of Directors at seven Directors, whereas the New Articles would increase this number to eight. The Company believes that this increase will provide the Company with sufficient flexibility to ensure an appropriate balance of skills, knowledge and experience as the Company has grown since the Current Articles were adopted in 2014.

## Director remuneration (Article 84)

The cap on the fees payable to Directors for their services in the office of Director has been increased from £200,000 in the Current Articles, to £325,000 in the New Articles. The current limit has been in place since 2014 and in line with the increase in the size of the Board, it is now proposed that it be increased in order to provide the Company with sufficient headroom and flexibility to expand the number of Non-Executive Directors and to maintain Non-Executive Director fees in line with the market.

## Proceedings at general meetings (including 'hybrid' meetings) (Articles 52A to 56A)

The New Articles would permit the Company to hold 'hybrid' general meetings whereby some attendees are based in a physical location, and others attend electronically.

The Company believes that introducing these provisions provides flexibility to the Company to navigate technological advances and market practice.

Certain consequential changes to facilitate this amendment have been made throughout the New Articles. In addition, a number of practical and technical amendments have been made to the provisions relating to shareholder meetings to bring these in line with best practice. These include articles dealing with electronic facilities and electronic security measures.

## <u>Untraced Members (Article 37)</u>

The New Articles amend the position in relation to untraced shareholders. Rather than requiring the Company to take out newspaper advertisements, the New Articles require the Company to use reasonable efforts to trace the shareholder. 'Reasonable efforts' to trace a shareholder may include, if appropriate, the Company engaging a professional asset reunification company or other tracing agent to search for a shareholder who has not kept their shareholder details up to date.

As under the Current Articles, the New Articles allow the Company to sell the shares of a shareholder who has been untraced for a period of 12 years or more. Whilst the Current Articles provide that the Company will be indebted to the shareholder for the proceeds of such sale, the New Articles provide that such monies will be forfeited to the Company if not claimed after two years of the sale.

These changes reflect best practice and provide the Company with appropriate flexibility in connection with locating untraced shareholders.
